

Purchase of updates within 1 year of the original system purchase or expiry of the previous update period:

Upgrade rights - one-time purchase	License Value
for 1 year	15%
for 2 year	25%
for 3 year	30%
for 4 year	40%
for 5 year	45%

Purchase of upgrades from 1 to 5 years after the purchase of the original system or the expiration of the previous upgrade period:

Upgrade rights - one-time purchase	License Value
for 5 year	60%

Purchase of upgrades after 5 years from the purchase of the original system or the expiration of the previous upgrade period:

Upgrade rights - one-time purchase	License Value
alignment to the latest version of VDG SENSE, IPROTECT, IMANAGER, COMMEND	60%
alignment to the latest version of WINGUARD	individual pricing


Why is it worth updating your system?

NIS2 compliant:

- Forcing passwords to be submitted to you OSDPv2
- AES 256 encrypted client-server communication
- Forcing passwords to be submitted to you
- Support for OSDPv2 protocol
- Database and password encryption
- No possibility of reading personal data by unauthorized persons
- An attacker can gain access to
- execute arbitrary commands on the server

New server:

- Risk of damage to the old server vs a new server that does not support the older version of the software
- IT security policy

64-bit architecture support:


- The same server will support more cameras

Introduction of the General Data Protection Regulation:


- Personal data must not be read by unauthorised persons = data must be encrypted




PURCHASE OF UPDATES IN THE PERIOD > 1 year < 5 years from SYSTEM PURCHASE

Upgrade Conditions:

1. The following systems can be updated: IPROTECT, VDG SENSE, IMANGER, WinGuard, Commend VirtuoSiS and Studio.
2. By purchasing the update, the Client acquires the right to personally perform system updates, i.e. the possibility of downloading the latest versions of the software during the period during which he will have a valid right to update.
3. The right to update is not the same as the update service, which is a separately priced service of updating the Client's systems by C&C Partners engineers.
4. The amount and entitlement of the offer depend on the period that has elapsed since the original purchase of the system or the end of the last period of entitlement to upgrade. There are three:
 - periods: < 1 year
 - > 1 year < 5 years
 - > 5 years
5. The Client's Upgrade Entitlement may be purchased in one of the purchase models depending on the period that has passed since the purchase of the system or the last update:
 - A) < 1 year One-time Purchase – the fee is paid on the day of purchase in advance for the entire period, acquiring the right for a period of 1/2/3/4/5 years.
 - B) > 1 year < 5 years One-time purchase – the fee constituting 60% of the license value is paid on the date of purchase in advance for the entire period, gaining the right to update for a period of 5 years from the date of the original system or the end of the last upgrade period.
 - C) > 5 years One-time purchase – the fee constituting 60% of the license value for VDG SENSE, IPROTECT and IMANAGER, COMMEND and individual pricing in the case of WINGUARD is paid on the day of purchase, ensuring a one-time update of the system to the latest version.
6. The date of completion of the right to upgrade is calculated as the period for which the Client purchased the rights counted from the date of the original purchase of the system or the end of the last period of the right to update.
7. One-time purchase – the Client signs a statement of familiarization with the rules of the right to update.
8. Extending a license that has the right to update with new elements (licenses) results in charging updates for these elements for the period remaining until the update expires.
9. For WINGUARD system without upgrade authorization, the system can only be extended to DPUs and workstations.
10. The offer for system updates is calculated by the C&C system according to the described rules.
